Riverwild Rental Policy

Riverwild is an appropriate setting for the small, intimate wedding or for larger groups gathering to celebrate birthdays, graduations, family or class reunions, etc. Its natural beauty, with an extensive collection of flowers, grasses, and shrubs that are in bloom from early spring to late fall, makes it unnecessary to bring in additional flora. Seating for 200+ is available on site on rocks bandstand seat wall, and benches.

All fees go directly toward maintenance and horticulture in Riverwild Garden.

- 1. To reserve a date, a \$1,000 money order or cashier's check (\$200 refundable damage deposit and \$800 rental fee entitling the renter to four hours beginning at 4:00 p.m. in Riverwild, including bandstand/terrace area, garden, playground, splashpad, and restroom) must be received by Delano Park Conservancy at least 1 month but no more than one year prior to the event. Security is required and included in the rental fee. Provided there is no property damage, the damage deposit monies will be returned within 30 days after the event. Events are limited to 200 people (including the wedding party in the case of weddings). The event, including associated set-up and clean-up must be completed within the hours reserved. Additional time will be charged at a rate of \$100 per hour. If one of the four hours is used for a wedding rehearsal, it must be pre-arranged to take place during regular garden hours. A refund of the rental fee and damage deposit fee will be made if the Parks Department or Delano Park Conservancy has to cancel the event. A refund of the rental fee will not be made if the renter cancels the event; however, the damage deposit fee will be refunded. In case of rain, the original party may reserve another time and/or date (if available) within three (3) months of the original reservation date at no additional charge.
- 2. Delano Park Conservancy will schedule an orientation with the party who signs the application (and the bride in the case of a wedding) to take place at Parks and Recreation 610 4th Av. S.E. at which time the permit will be issued. Bring permit with you to Riverwild on the day of the event. Park Department, Friends of Delano Park, the Conservancy, or security personnel may ask to see it.
- 3. Absolutely nothing may be added or attached in any fashion to the bandstand, bathhouse, any plant, rock, sculpture, sign or other structure. All decorations must be free standing.
- 4. Entering the flower beds or picking flowers is prohibited.
- 5. Musicians and their equipment are permitted on paved areas only and in the bandstand **not** in the grasses, flower beds, or paths. Amplification of music or for other purposes is **not** allowed.
- **6.** Rice, bird seed, silk flower petals, and confetti from any source are **not** permitted.
- 7. Sidewalk chalk, canned confetti string (e.g. Silly String), and stickers are prohibited.
- 8. Wax candles and tents are **not** allowed. Chairs and tables are allowed on paved areas and in the bandstand only **not** in the grasses or flower beds.
- 9. Existing Riverwild furnishings and fixtures must remain in place without exception.
- 10. All areas must be cleaned and all equipment removed immediately after an event. Trash must be bagged and placed beside the trash can on Prospect Drive. Damage deposit will be withheld if facility is not cleaned.
- 11. This is a No Smoking Zone.
- 12. Alcohol is allowed only with proper city licensing.
- 13. Events may not continue past dark.
- **14.** Neither the Parks and Recreation Department nor Delano Park Conservancy are responsible for any items left unattended.
- **15.** All vehicles must remain on paved areas only. Loading and unloading with hand trucks is permitted from Prospect Drive wheelchair ramp provided hand trucks remain on paved areas only.
- **16.** Renter will be responsible for any damage done to the hardscape or landscape. Delano Park Conservancy will conduct inspections prior to and after each event.
- 17. Only non-profit 501(c)3 organizations may use the garden for fundraising with prior Parks and Recreation and Delano Park Conservancy approval and permit. Approved 501(c)3 organizations will receive a 25% discount on their rental fee.
