Riverwild Splashpad Rental Policy

The Riverwild WPA-style splashpad is an appropriate setting for birthday parties or family gatherings. Bench seating for 20 + is available in addition to the seat wall for 30 +. All fees go directly toward maintenance and horticulture in Riverwild.

- 1. To reserve a date, a \$300 money order or cashier's check (\$100 refundable damage deposit and \$200 rental fee entitling the renter to four hours in the Splashpad area during regular park hours) must be received by the Delano Park Conservancy at least 7 days but no more than one year prior to the event. Provided there is no property damage, the damage deposit monies will be returned within 30 days after the event. Events are limited to 50 people. The event, including associated set-up and clean-up must be completed within the hours reserved. Additional time will be charged at a rate of \$50 per hour. A refund of the rental fee and damage deposit fee will be made if the Parks Department or Delano Park Conservancy has to cancel the event. A refund of the rental fee will not be made if the renter cancels the event; however, the damage deposit fee will be refunded. In case of rain, the original party may reserve another time and/or date (if available) within three (3) months of the original reservation date at no additional charge.
- 2. A permit will be issued upon receipt of the rental fee. Bring permit with you to Riverwild Splashpad on the day of the event. Park Department, Friends of Delano Park, the Conservancy, or security personnel may ask to see it.
- 3. Absolutely nothing may be added or attached in any fashion to the bathhouse, any plant, rock, sculpture, sign or other structure. All decorations must be free standing.
- 4. Rice, bird seed, silk flower petals, and confetti from any source are not permitted.
- 5. Sidewalk chalk, canned confetti string (e.g. Silly String), and stickers are prohibited.
- **6.** Entering the flower beds or picking flowers is prohibited.
- 7. Amplification of music or for other purposes is **not** allowed.
- **8.** Wax candles and tents are **not** allowed. Chairs and tables are allowed on the concrete surrounding the splashpad **not** in the grasses or flower beds.
- 9. Existing garden furnishings and fixtures must remain in place without exception.
- **10.** All areas must be cleaned and all equipment removed immediately after an event. Trash must be bagged and placed beside the trash can on Prospect Drive. Damage deposit will be withheld if facility is not cleaned.
- **11.** Smoking and alcohol are prohibited. This is a **No Smoking Zone**.
- **12.** Events may **not** continue past dark.
- **13.** Neither the Parks and Recreation Department nor Delano Park Conservancy are responsible for any items left unattended.
- **14.** All vehicles must remain on paved areas only. Loading and unloading with hand trucks is permitted from Prospect Drive wheelchair ramp provided hand trucks remain on paved areas only.
- **15.** Renter will be responsible for any damage done to the hardscape or landscape. Delano Park Conservancy will conduct inspections prior to and after each event.
- **16.** Only non-profit 501(c)3 organizations may use the splashpad for fundraising with prior Parks and Recreation and Delano Park Conservancy approval and permit. Approved 501(c)3 organizations will receive a 25% discount on their rental fee.
